KGGTF is pleased to announce the launch of its Annual Report 2023. The Report summarizes KGGTF activities, performances, and impacts in 2023. Since its inception, grant-funded programs have been linked to \$24 billion in World Bank lending and co-financing, translating to an impressive investment effect of \$202 for every \$1 of grant funds approved.

Leveraging Korea's Expertise in Battery Storage for Ukraine's Energy Sector

The ongoing war with Russia has inflicted severe damage on Ukraine's energy infrastructure, incurring over \$10.6 billion in costs and slashing electricity production capacity by 61%. This crisis underscores the urgent need for a comprehensive overhaul of the energy system. This KGGTF grant aims to support Ukraine in developing its ability to increase its energy resiliency by expanding renewable energy sources.



Mongolia Wastewater Treatment and Reuse



This knowledge exchange, which took place on April 23-27, 2024, achieved its objectives of deepening knowledge on wastewater treatment, reuse technologies, and best practice management systems on industrial water recycling based on the Korean experience. It also facilitated a collective understanding of circular economy principles amongst stakeholders to encourage shared ownership of the proposed solution and encouraged discussion amongst the participants on coordination, financing, and regulatory hurdles to implement the proposed solution.

The grant, Mongolia: Utilization of treated water from over melting ice in the "ger" district area for the heating system in eastern part of Ulaanbaatar city, was approved in 2020, led by James Tay, Water Specialist.

Extended Producer Responsibility (EPR) System on Plastic Packaging in the Philippines



This knowledge exchange, which took place on April 22-26, 2024, brought together relevant agencies in the Philippines at a timely stage in the development of the country's EPR policy. Site visits to various agencies and facilities involved in EPR operations led to key learnings from Korea's EPR policy implementation experience.

The grant, Exchange of Circular Economy Experiences with Korea, was approved in 2023, led by Junu Shrestha, Senior Environmental Specialist.


